Supply Chain Management – A reliable partner for the SCM needs of our customers.




Agencies – Your choice for marketing solutions, sales and customer services.

HISTORY

Founded in 1967 in Como, Italy, Giorgio Giamminola & C. is the historical seat of ITG GROUP.

In 2011 the seat was strategically transferred to the modern installations located in Shanghai.

The Company expanded, during the 1990s, with the establishment of subsidiaries: from Europe to Africa, from Central and South America to Asia.

Today, the Group comprises fifteen units and is present worldwide through an extensive network of agents and distributors.



1967 - Establishment

GIORGIO GIAMMINOLA & C. is founded in Como, Italy, specializing in the supply of spare parts, accessories, yarns, and textile machineries.

1980 - Acquisition

After the first steps of expansion in Libya and Algeria, in the 80's ITG GROUP enters Northern African markets, including Egypt. With the acquisition of Tac Tessile Accessorio, activities are also expanded in Italy. Moreover, OMITA S.p.A. is acquired, taking advantage of the exclusive sales of spare parts worldwide.

1990/2000 - Internationalization and industrialization

The Group expands in Europe, Africa, Central and South America, establishing technical and commercial enterprises to ensure a better support and local presence to its customers. The Group also invests in two industrial realities in Argentina: FILOTEX SRL in 1996, and ITALCOLORE SA in 2004.

2008 - Centralization of operations and restructuring

After 15 years of presence in Asia with a JV, the Group establishes Giamminola Shanghai Co., Ltd. The first steps are taken to lay the foundations for a new structure transcending the family business.



2011 - Social Responsibility

ITG Energy is created with focus on the development of energy saving solutions.
